DISCUSSION OF PROPOSED BUDGET (Mr. Flom and Mr. Jacobs)

Mr. Jacobs shared that in addition to budget approval, the Budget Committee will also be asked to approve the tax levies. Mr. Jacobs then reviewed the tax levies. Mr. Jacobs shared there was a question received regarding the Ag Center. The Budget Committee had some additional questions about Ag Center construction timeline and potential programming. Mr. Jacobs, Mr. Flom and Dr. Buchele responded to satisfaction.

APPROVAL OF FY24 Budget (Chair Malone)

Ms. Adams moved that the Budget Committee of Linn-Benton Community College approve the budget for the 2024-25 fiscal year in the amount of \$156,964,808. Seconded by Mr. Running. Motion for the Budget Committee of Linn-Benton Community College to approve the budget for the 2024-25 fiscal year in the amount of \$156,964,808 was approved unanimously. (12,0).
